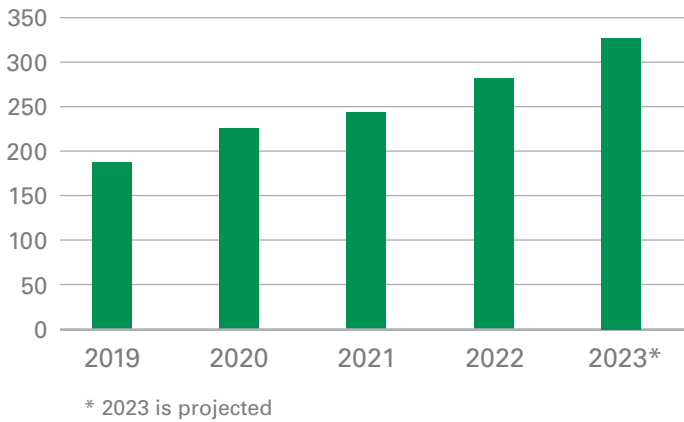

- A+ rating from S&P Global Ratings and Fitch Ratings (both confirmed August/September, 2022)

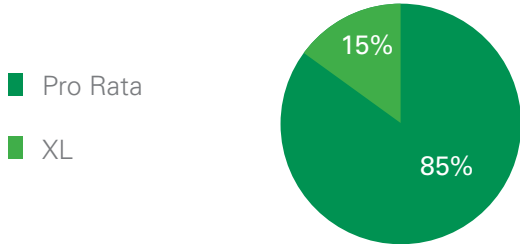
Portfolio Structure

Gross Written Premium (CHF/m)

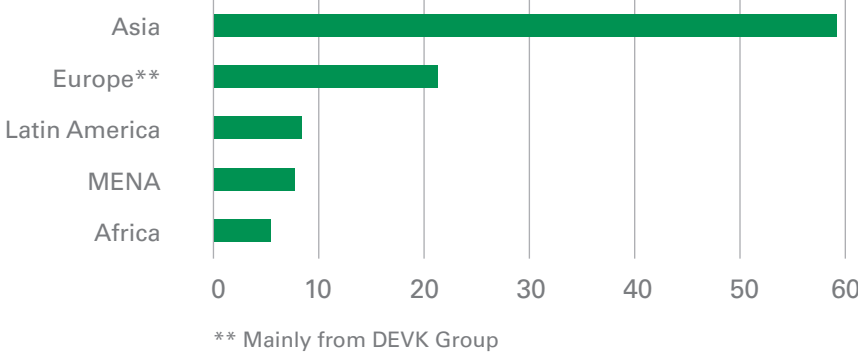


GWP by Type of Treaty

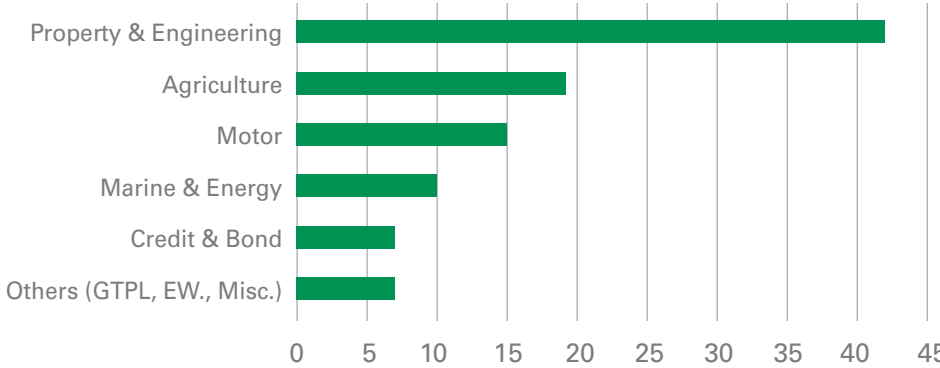


Lines of Business
